### **NON-MEMBER PARTICIPATION FEE**

24-12-3. Non-member Participation Fee

A) An annual non-member participation fee for awards and titles will be charged to a Canadian non-member of CKC. The fee will match the ERN fee.

In order to protect the awards/titles earned, the non-member will have a choice either to become a CKC member or to pay the non-member participation fee. Failure to comply within 30 days of notification will cause all awards and titles to be cancelled.

### **ATTENTION FOREIGN EXHIBITORS**

ERN Numbers must be applied for within 30 days of the first day of entering a CKC Event. A CKC ERN registration form can be downloaded from the CKC website: <http://www.ckc.ca>. The request can then be forwarded to the Canadian Kennel Club, 400-200 Ronson Drive, Etobicoke, ON M9W 5Z9 or faxed to: 416-675-6506.

***Section 18.1 of the CKC Herding Rules states:***

“The CKC shall not be responsible to any member, person, partnership, club or corporation for any loss, damage or injury arising at or by reason of any herding trial held under any rules adopted by the CKC.”

***Section 15.7 of the CKC Herding Rules states:***

“It shall be the duty and obligation of the trial-giving club to see that a judge, club official, ring steward volunteer or competitor at a Herding Trial held under these regulations, is not subject to indignities of any kind. The Herding Trial Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. A copy of this regulation shall be prominently placed in every premium list and catalogue.”

# Directions to Phantom Ridge Farms:

Coming from Calgary:

South on Hwy 2, turn off of Hwy 2 at Aldersyde overpass (also Hwy 547), go east on Hwy 547 for 11.5 kms, turn south on 176th Street (there is a big power station on the corner), proceed 3.5 kms south. The Farm is on the west side of the road. Little pinkish house on the hill. Also have a three rail fence that runs along the road.

Coming from South of High River on Hwy 2:

North of High River on Hwy 2, turn off on Hwy 2 at Aldersyde overpass (also Hwy 547), go east on Hwy 547 for 11.5 kms, turn south on 176th Street (there is a big power station on the corner) and proceed 3.5 km South. The Farm is on the west side of the road. Little pinkish house on the hill. Also have a three rail fence that runs along the road.

Coming from the East on Hwy 1:

In Strathmore turn south on Hwy 817 (also Wheatland Trail. There are lights and an Esso Truck Stop at that corner), follow along Hwy 817 until you T into Hwy 24, you will cross Hwy 901, south on Hwy 24. When Hwy 24 makes a sharp curve to the east, you will turn west on Hwy 547. Take Hwy 547 west to 176th Street (approx. 15 minutes, a long ways), then south on 176th Street for 3.5 kms.

## GENERAL RULES

1. Entries must be received by the Show Secretary prior to closing date. Withdrawal of entries prior to closing date may be made by telephone, but must be followed up in writing to **reach the Show Secretary by closing day** (mail, email).
2. No entry form will be accepted unless all particulars called for on the entry form are complete. Incomplete entries will be returned. No entry will be accepted unless accompanied by the entry fees. Telephone or email entries will not be accepted.
3. Exhibitors must abide by errors made in entering their dogs regardless of how, or by whom the entry was made. Changes after the closing date are prohibited.
4. RCC reserves the right to refuse any entry subject to CKC Rules.
5. The Show Superintendent will have full charge of the show. 2012 CKC Herding rules will be followed.
6. **Please keep your area clean.**
7. **All dogs must be exercised in the exercise areas stated at the handler's meeting. Please clean up after your dog. Exhibitors must clean up ALL of their messes.**
8. No dog will be allowed on or near the trial arena unless entered in the show. Demonstration dogs are exempt. Please respect the handler and dog that are trialing at the time you are watching and ensure that your dog is no where in the vicinity of the sheeps' line of sight. We ask that all Exhibitors respect this and will be notified if your dogs are too close. Therefore no benching near the arena will be allowed. **NO EXCEPTIONS!!**
9. No refund of entry fees will be made if it is impossible to open or complete the trials because of riot, civil disturbance, or other acts beyond the control of the RCC.
10. RCC will use due care and diligence for the welfare of dogs and exhibitors but will not be responsible for or assume any liability in the event of accident or other mishap caused to either dogs, exhibitors or spectators whether the results of accident or otherwise. A dog should not be touched without the permission of the owner or handler.

11. Any dog excused by the Show Superintendent or Veterinarian for any reason shall not, after being excused, compete in any trial or for any awards for the balance of the trial.

12. Judging schedules will be emailed as soon as possible after entries close. Should these not be received within a reasonable period of time, please notify the Show Secretary.

13. A dog will be called three (3) times for judging, after which it will be marked absent.

14. Dogs and handlers should be at the trial facility 1 hour prior to judging. It is the responsibility of the owner or handler to have the dog "on deck" near the arena prior to their run. Handlers are requested to report any absentees and have a runner at arena side if they are engaged elsewhere to request a change in the running order.

15. This will be a **NON-SMOKING** event during the judging of any dog in the arena area. This rule will be strictly enforced. , as this is an outdoor facility during the summer months around hay and grass. NO cigarettes will be extinguished on the grass or hay areas. There are gravel areas where one can put out their cigarettes and then place the extinguished cigarette in the trash receptacles around the area.

**It shall be deemed unsportsmanlike conduct if a person, during the running of or in connection with an event, abuses or harasses a judge, show official, or any other person present at the event, including all animals present as well**
